AN INTRODUCTION TO MECHANIC'S LIENS

Mechanics, artisans, and materialmen enjoy certain rights and protections under Texas law Specifically, Article XVI, Section 37 of the Texas Constitution grants to mechanics, artisans, and materialmen a claim or interest upon the buildings and articles made or repaired by them for the value of labor done thereon or material furnished therefor

FLORIDA MECHANIC'S LIEN LAW 2018-2019

A general contractor or subcontractor must be licensed in order to avail itself of a mechanic's lien However, the lack of a license does not affect the rights of other persons to file Lien Section 71302(7)) For example, assume the general contractor is not licensed and subs out the work to an electrician

Changes Made to the Pennsylvania Mechanics' Lien Law to ...

The legislation also amended the Mechanics' Lien Law to limit the extent to which the owners of residential property are subject to mechanics' liens The legislation provides that a lien claim filed with respect to a residential property may be discharged when the owner or a tenant has paid the full contract price to the contractor
