Since 2007, Ohio law has required that all contractors and subcontractors enroll in a drug-free workplace program to be eligible to perform public construction work in Ohio Failure to comply with this requirement is considered a breach of contract and may prevent a contractor from receiving a public contract for up to five years ORC §15303
