Effective January 1, 2008, Florida's Portability Law (193155(8), FS) is a benefit associated with homestead property Portability allows property owners to transport the accumulated 'Save Our Homes' benefit (up to \$500,000) earned on a previous homestead property (in any Florida county) to their new home

Apply by March 1, 2008, to transfer your "Save Our Homes ...

The "Save Our Homes" benefit is the difference between the assessed value and market value of a homestead property due to the annual limit on increases in assessed value. Portability means that, from now on, you can transfer some or all of your old home's "Save Our Homes" benefit to your new home.

Portability General Information

A: Florida Statute 193155(8) states that may transfer your CAP if you have, "...received a homestead exemption as of January 1 of either of the 2 immediately preceding years" In other words, you may only go one tax year without having a homestead exemption in order to transfer your CAP. Thus, if
